



I am please to announce that on October 1<sup>st</sup> 2013, Bellalago and Isles of Bellalago went live on the new Gatehouse Security program called Dwelling Live. Thank you for your patience as we worked through the kinks with transponders. We believe we have now transferred all the transponder numbers from our old system and have tested the software enough to start the transition to resident control. (If you are having any issues with your transponder, please let the front desk know). We need the number on the back that starts with 26 XXXXX (five digit).

Dwelling Live offers many features that allow the resident to manage their personal information. Residents can add or delete entries on their guest list, and update automobile and other personal information direct from within their account as long as they have access to the web. You will be able to control the access to your home. You can change your profile, guests, vendors, vehicles, and even have “party” access lists for when you have gatherings at your home.

You need to register for your unique user name and password, by completing the attached form. This can be emailed or dropped at the amenity centers for processing. If you are a homeowner and have tenants in your home – they will need to register also. AAM suggests making this part of your lease agreement.

Once the registration is processed you will receive an email with your access and a tutorial to assist you. Even though this program is very user friendly, we understand that not everyone has computer skills, or indeed access to a PC and the internet. We will work with those that need help. Registration will usually take less than 24 hours, however as we start this process we will input the details as fast as possible, so please be patient as we have 1250 homes to input details for.
